Current Year to Date Financial Status Update

Mr. Grissom gave an update on the financial status. This reporting is through April. 97.3% of the budget is expected to be expended. All financial obligations are expected to be met. Expenses are trending well for the year.

Cafeteria Fund Update

Mr. Grissom gave a brief update on the cafeteria reporting. This reporting is through April. The district has served over 27,000 meals. The revenue is from reimbursement from the State. The same meal program will be offered through the summer as in the previous two years. Auditors will review and make suggestions on what should be done with the surplus. Capital items may be identified. This program will not be extended next year.
