Mr. Fitton feels this is dangerous and will discuss with our legislative representatives to possibly increase the speed. Mr. Riley questioned Mr. Kulick regarding the recent incident involving our high school students traveling to Waterbury for a musical awards night. Mr. Kulick noted that the roads were slick. The driver reported a mechanical difficulty. A replacement bus arrived to transport students back to Valley Regional. After the driver left the Palace Theater, the driver felt unable to transport the students. Students waited in a commuter lot for a replacement driver to arrive. The driver is no longer driving for our bus company. Mr. Kulick noted that there was no forewarning that the driver would unable to drive the bus. Mr. Riley said that we need to have a better understanding of what happened. He requested an incident report. Mr. Riley noted that it was disappointing that this was not mentioned during the end of year report.
