### Vote on Superintendent's Recommendation to appoint Shipman and Goodwin as legal counsel for Supervision District for 2016-17.

Shipman and Goodwin have provided services for many years to our district. They are a firm that has both depth and knowledge. Mr. Henick has worked with them on the Policy Committee and they have been quite helpful.

Upon a motion made by DG Fitton and seconded by Lon Seidman the Supervision District Committee unanimously **VOTED** to appoint Shipman and Goodwin as legal counsel for Supervision District for 2016-2017.
